



Official Contest Rules

Eligibility

myGECreditUnion.com Website Scavenger Hunt (the Contest) is open to members of GE Credit Union who are at least eighteen (18) years old at the time of entry with a valid email and phone number on file. Submissions with non-matching phone number and emails will be disqualified. Current members must be in good standing. New members are eligible to participate on the date the membership/account becomes active. Employees, Directors, and Officers of GE Credit Union are not eligible. Non-members and owners/signers of a Representative Payee Account, Trust Account, Estate Account, Sole Proprietorship Account, or Business/Organization Account are not eligible.

- **Sponsor**

The Contest is sponsored by GE Credit Union, located at 265 Sub Way, Milford CT 06461.

- **Agreement to Official Rules**

Participation in the Contest constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. Winning a prize is contingent upon being compliant with the Official Rules and fulfilling all other requirements set forth herein.

- **Contest Period**

The Contest begins on October 2, 2017 and ends October 31, 2017 at 5:00 pm EST (the "Contest Period"). Entries submitted before or after the Contest Period will be disqualified.

- **How to Enter**

Submissions will be accepted for the duration of the Contest using the following method: Entrant must access www.myGECreditUnion.com in order to view the questions. Entrant must read the Scavenger Hunt Question, search www.myGECreditUnion.com, and complete the sentence provided by selecting the correct multiple-choice option. Entrant must also Like GE Credit Union on Facebook. Limit one (1) entry per member.

- **Prize Drawings**

- **10 Winners**—Winners will be selected in a random drawing from all eligible entries correctly answering the Scavenger Hunt questions. Answers must be submitted by 5:00 PM EST on Tuesday, October 31, 2017 to be eligible.
- **Grand-Prize Winner**—One winner will be selected in a random drawing from all eligible entries to correctly answer all Scavenger Hunt questions.

- **Winner Notification**

Winners will be notified by Friday November 2, 2017. Winners will be notified via contact information on file. If Sponsor is unable to notify the winner due to incorrect or outdated information on file, an alternate winner will be selected. Upon notification and verification of identity, the winner may be asked to come to a specific GE Credit Union office for a brief presentation ceremony.

Winner hereby irrevocably consents to and authorizes Sponsor and its agents or anyone else authorized by Sponsor, to use and reproduce any and all photographs or other types of images, voice recordings and/or video or writings that Sponsor takes or records related to the Contest. Images, recordings, videos or writings, with or without winner's name, may be used for any purpose, whatsoever, including but not limited to, purpose of



publicity, advertising, banners, illustration, posters, publications, writings and web content, in connection with Sponsor in print or electronically.

- **General Conditions**

In the event that the operation, security, or administration of the Contest is impaired in any way for any reason, including, but not limited to fraud, malicious code, unauthorized human intervention or other technical problem, or in the event the Contest is unable to run as planned for any other reason, as determined by Sponsor in its sole discretion, the Sponsor may either (a) suspend the Contest to address the impairment and then resume the Contest in a manner that best conforms to the spirit of these Official Rules or (b) terminate the Contest. The Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to damage the website or undermine the legitimate operation of the Contest may be in violation of criminal or civil law, and, should such an attempt be made the Sponsor reserves the right to seek damages (including attorney's fees) and any other remedies from any such person to the fullest extent permitted by law. Failure by the Sponsor to enforce any provision of these Official Rules shall not constitute a waiver of that provision or any other provision.

- **Release and Limitation of Liability**

By participating in the Contest, entrants agree to release and hold harmless the Sponsor, and each of their Officers, Directors, employees, representatives, and agents (the Released Parties) from and against any claim or cause of action arising out of participation in the Contest or receipt or use of the prize (including any travel or activity related thereto), including, but not limited to: (a) any technical errors associated with the Contest, including lost, interrupted or unavailable Internet Service Provider (ISP), network, server, or other connections, availability or accessibility or miscommunications or failed computer transmission or computer hardware or software malfunctions, failures or difficulties; (b) unauthorized human intervention in the Contest; (c) mechanical, network, electronic, computer, human, printing or typographical errors; (d) any other errors or problems in the administration of the Contest, the announcement of the winner, or the cancellation or postponement of the events; or (f) injury, death, losses or damages of any kind, to persons or property which may be caused, directly or indirectly, in whole or in part, from entrants participation in the Contest or acceptance, receipt or misuse of the prize (including any travel or activity related thereto). Entrant further agrees that in any cause of action, the Released Parties are also not responsible for any incorrect or inaccurate information, whether caused by site users, tampering, hacking, or by any equipment or programming associated with or utilized in the Contest. Entrant waives the right to claim any damages whatsoever, including, but not limited to, punitive consequential, direct, or indirect damages.

- **Disputes**

Except where prohibited, each entrant agrees that any and all disputes, claims and causes of action arising out of, or connected with, the Contest or any prize awarded shall be resolved individually and in the sole judgment of Sponsor, without resort to any form of class actions. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, entrants' rights and obligations, or the rights and obligation of the Sponsor in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the state of Connecticut.
